CONTRACT AGREEMENT

THIS AGREEMENT, made this JUL 02 2020 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **MARC JILL CONSTRUCTION** with office address Violet St., Lumangbayan, Calapan City, Oriental Mindoro represented by **ENGR. ESTELA S. MACAPAGAL**, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Renovation of 3 Classroom at Eufrancio Carmona ES, Malaya, Naujan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **NINE HUNDRED EIGHTY FIVE THOUSAND EIGHT HUNDRED SIXTY NINE PESOS AND 25/100 (Php 985,869.25)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
