THIS AGREEMENT, made this MAY 05 2020 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camiimil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **876 CONSTRUCTION & SUPPLY** with office address at Malamig, Calapan City, Oriental Mindoro represented by **ROBERTO B. YLAGAN**, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Completion of Senior Citizens Hall at Barangay Tagumpay, Baco, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **FOUR HUNDRED EIGHTY ONE THOUSAND FOUR HUNDRED FIFTY TWO PESOS AND 01/100 ONLY (Php 481,452.01)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
