THIS AGREEMENT, made this MAY 2020 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and 876 CONSTRUCTION & SUPPLY with office address at Malamig, Calapan City, Oriental Mindoro represented by ROBERTO B. YLAGAN, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Completion of Senior Citizens Hall at Barangay Tagumpay, Baco, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount FOUR HUNDRED EIGHTY ONE THOUSAND FOUR HUNDRED FIFTY TWO PESOS AND 01/100 ONLY (Php 481,452,01) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
