CONTRACT AGREEMENT

THIS AGREEMENT, made this JUN 19 2020 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and B5 BUILDERS & SUPPLIES with office address Libis, Calapan City, Oriental Mindoro represented by BERNARDO O. APACIBLE, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Rehabilitation of Multi-Purpose Building at San Nicholas, Naujan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION FOUR HUNDRED FORTY THOUSAND FOUR HUNDRED FORTY EIGHT PESOS AND 03/100 ONLY (Php 1,440,448.03) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
