CONTRACT AGREEMENT

THIS AGREEMENT, made this JUN 25 2020 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camiimil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and RADEL CONSTRUCTION with office address along C-5 Road, Sta. Isabel, Calapan City, Oriental Mindoro represented by ENGR. ADELFA P. PEREZ, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Drainage Canal at Sitio Catechist Lane to Block 5, Brgy. Pachoca, Calapan City, Oriental Mindoro/ Construction of Drainage Canal at Sitio Pagkakaisa, Brgy. Lumangbayan, Calapan City, Oriental Mindoro/ Construction of Drainage Canal at Brgy. Canaan, Victoria, Oriental Mindoro/ Completion of Drainage Canal at Lawaan St., Nacoco, Calapan City, Oriental Mindoro and Construction of Open Canal Protection at Barangay Bayanan, Baco, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount TWO MILLION FOUR HUNDRED THIRTY THREE THOUSAND EIGHT HUNDRED NINETY ONE PESOS AND 71/100 ONLY (Php 2,433,891.71) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
