**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

Resolution No. 082, Series of 2020

WHEREAS, there is an infrastructure project funded through the **DRRM FUND 2019** to be undertaken by the Provincial Government of Oriental Mindoro for the **Construction of Gabion at Sitio Tagascan, Brgy. San Vicente, Roxas, Oriental Mindoro (Construction of Gabion: L=24.00m; Ht.=4.00m);**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2020-084) in PhilGEPS Website on **June 6, 2020** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Construction of Gabion at Sitio Tagascan, Brgy. San Vicente, Roxas, Oriental Mindoro (Construction of Gabion: L=24.00m; Ht.=4.00m);**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. MDH CONSTRUCTION

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **June 26, 2020**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **June 26, 2020** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **MDH CONSTRUCTION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **June 26, 2020** found out that bid price of **MDH CONSTRUCTION** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;

WHEREAS, upon careful examination, validation and verification of eligibility, technical, financial requirements submitted by **MDH CONSTRUCTION** with **Single Calculated Bid**, its bid passed the post qualification process conducted on **June 30, 2020**, thereby making its bid found to be responsive;

NOW, THEREFORE, We the Members of the Bids and Awards Committee, in our meeting on **July 6, 2020** hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a) To declare **MDH CONSTRUCTION** with business address at **327 College Road, Brgy. 58, Pasay City, Metro Manila** as the bidder with **Single Calculated Responsive Bid**.
