**WHEREAS**, there is an infrastructure project funded through the **DOH Trust Fund** to be undertaken by the Provincial Government of Oriental Mindoro for the **Infrastructure Project (Phase II) for Oriental Mindoro Rehabilitation and Recovery Center, Brgy. Ilaya, Calapan City, Oriental Mindoro (Repair/Rehab of Oriental Mindoro Rehabilitation and Recovery Center (P-II) )**;

**WHEREAS**, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2020-102) in PhilGEPS Website on **July 1, 2020** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the the **Infrastructure Project (Phase II) for Oriental Mindoro Rehabilitation and Recovery Center, Brgy. Ilaya, Calapan City, Oriental Mindoro (Repair/Rehab of Oriental Mindoro Rehabilitation and Recovery Center (P-II) )**;

**WHEREAS**, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

**1. SANDBANK CONSTRUCTION AND DEVELOPMENT**

**WHEREAS**, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **July 20, 2020**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

**WHEREAS**, during the opening of Bid on **July 20, 2020** eligibility check was conducted to one **bidder/contractor** mentioned above and were found eligible by the BAC;

**WHEREAS**, the bid proposals submitted by **SANDBANK CONSTRUCTION AND DEVELOPMENT** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
