

3. Surety bond callable upon demand issued by a surety or Insurance company duly certified by the Insurance Commission as authorized to issue such security.	Thirty percent (30%)



Failure of your office to post the Performance Security and sign the contract within the same ten (10) day period shall result in the following:

1. Forfeiture of the bid security;
2. Cancellation of award of contract;
3. Disqualification from participating in the bidding at hand;
4. Upon determination of administrative liability through blacklisting proceedings, it will suffer the corresponding penalty of suspension.
