WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City at **10:00 a.m of June 9, 2020**, the proceeding was in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, all bids were examined and found substantially complied with the technical and financial proposals, thereby making all bids passed the preliminary examination with their bid price as read shown hereunder;
