THIS AGREEMENT, entered into this 13th day of November 2019 between the PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camiling, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, PHD. Provincial Governor hereinafter called the "FIRST PARTY" and BONGABONG VIEW HOTEL & BISTRO with office address at Bongabong, Oriental Mindoro represented by MS. LEONISA U. CACHHA, Proprietress hereinafter called the "SECOND PARTY".

WHERE AS, the FIRST PARTY is desirous that the SECOND PARTY will provide the catering services with venue and accommodation to be used in the conduct of Training on Leveling Up Farmers competency Towards Food Security on November 21-22, 2019 at Bongabong, Oriental Mindoro in the amount ONE HUNDRED FIFTY THREE THOUSAND SIX HUNDRED PESOS (Php 153,600.00) with the following agreement as follows:

1. That the Second Party will provide necessary facilities for the catering services with venue and accommodation to be used in the conduct of Training on Leveling Up Farmers competency Towards Food Security for the Province of Oriental Mindoro.
2. That the FIRST PARTY will pay the amount of One Hundred Fifty Three Thousand Six Hundred Pesos (Php 153,600.00) from the Agricultural Services, Operations, Agro Technology Resource Mgt. Services, Institutional Development and Training Expenses of PAGO.
3. That the SECOND PARTY will be the one to shoulder all expenses in terms of catering services with venue and accommodation to be used in the conduct of Training on Leveling Up Farmers competency Towards Food Security on November 21-22, 2019 at Bongabong, Oriental Mindoro, to be incurred during the pendency of the contract.
4. That in case of breakdown of facilities in the aforementioned date and event the SECOND PARTY will be the one to shoulder the cost of repair expenses without any additional charge from the FIRST PARTY for this purpose.
