CONTRACT AGREEMENT

THIS AGREEMENT, entered into this 28th day of November, 2019 between the PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, PHD, Provincial Governor hereinafter called the "FIRST PARTY" and CECILIA PARTY NEEDS & CATERING SERVICES with office address at Calapan City, Or. Mindoro represented by MS. CECILIA T. DIGNO, Proprietress, hereinafter called the "SECOND PARTY".

WHEREAS, the FIRST PARTY is desirous that the SECOND PARTY will provide catering services with rental of tables for the conduct of IO 9001: 2015 Awareness, Documentation Training & Risk Based Thinking & Workshop at Calapan City, Oriental Mindoro in the amount equivalent to FIFTY THOUSAND FOUR HUNDRED PESOS (Php 50,400.00) with the following agreement as follows:

1. That the SECOND PARTY shall provide the tables/chairs and shoulder all expenses incurred for the installation and demobilization and replaced the defective chairs/tables if ever happen during the date and time of events without additional charge from the First Party for this purpose.
2. That the FIRST PARTY will pay the amount of fifty thousand four hundred Pesos (Php 50,400.00) from the Administrative Management Services, Operations, Organizational performance Management and Training Expenses – ISO from PA office
3. That the SECOND PARTY will be the one to shoulder all expenses in terms of catering services with rental of tables for the conduct of IO 9001: 2015 Awareness, Documentation Training & Risk Based Thinking & Workshop at Calapan City, Oriental Mindoro to be incurred during the pendency of the contract.
4. That in case of breakdown of facilities in the aforementioned date and event the SECOND PARTY will be the one to shoulder the cost of repair expenses without any additional charge from the FIRST PARTY for this purpose.
