CONTRACT AGREEMENT

THIS AGREEMENT, entered into this 20th day of January 2020 between the **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, PHD**, Provincial Governor hereinafter called the "FIRST PARTY" and **PARANG BEACH RESORT** with office address at Calapan City, Oriental Mindoro represented by **MR. BENJAMIN CACHA**, Proprietor, hereinafter called the "SECOND PARTY".

WHEREAS, the FIRST PARTY is desirous that the SECOND PARTY will provide the Catering Services with Accommodation to be used in the conduct of Regional Project Advisory Board site visitation and business meeting on January 26-28, 2020 at Calapan City, Oriental Mindoro in the amount of **SIXTY THREE THOUSAND FIVE HUNDRED PESOS (Php 63,500.00)** with the following agreement as follows:

1. That the Second Party will provide necessary facilities for the Catering Services with Accommodation to be used in the conduct of Regional Project Advisory Board site visitation and business meeting on January 26-28, 2020 at Calapan City, Oriental Mindoro for the Province of Oriental Mindoro.
2. That the FIRST PARTY will pay the amount of Thirty Seven Thousand and Fifty Pesos (Php 63,500.00) from the Special Purpose Appropriation, Cost Sharing Program, Counterpart for PRDP, PRNDP, Power, CRGG & other PPs, and Representation expense of PAGO.
3. That the SECOND PARTY will be the one to shoulder all expenses in terms of Catering Services with Accommodation to be used in the conduct of Regional Project Advisory Board site visitation and business meeting on January 26-28, 2020 at Calapan City, Oriental Mindoro to be incurred during the pendency of the contract.
4. That in case of breakdown of facilities in the aforementioned date and event the SECOND PARTY will be the one to shoulder the cost of repair expenses without any additional charge from the FIRST PARTY for this purpose.
