2. That the FIRST PARTY will pay the amount of Eighty Four Thousand Pesos (Php 84,000.00) from the Operation, Family Welfare Services, Capacity Development, and Training Expenses of PSWDO.

3. That the SECOND PARTY will be the one to shoulder all expenses in terms of **WHEREAS**, the FIRST PARTY is desirous that the SECOND PARTY will provide the Catering Services with Accommodation and Sound System for use of Leadership Training for Local Council of Women Leaders in Oriental Mindoro on February 27-28, 2020 at Calapan City, Oriental Mindoro to be incurred during the pendency of the contract.

4. That in case of breakdown of facilities in the aforementioned date and event the SECOND PARTY will be the one to shoulder the cost of repair expenses without any additional charge from the FIRST PARTY for this purpose.
