JUL 1 7 2020 THIS AGREEMENT, made this between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and KING'S BUILDERS & DEVELOPMENT CORP. with office address at Poblacion, Bongabong, Oriental Mindoro represented by JOHN MICHAEL K. MALALUAN, President, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Repair/Rehabilitation of Bridge Approach at Brgy. Putican Cabulo, Baco, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE MILLION NINE HUNDRED FORTY THOUSAND ONE HUNDRED FOUR PESOS AND 90/100 (Php 9,940,104.90) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
