CONTRACT AGREEMENT

THIS AGREEMENT, made this MAY 08 2020 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and 876 CONSTRUCTION & SUPPLY with office address at Malamig, Calapan City, Oriental Mindoro represented by ROBERTO B. YLAGAN, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Senior Citizen's Building (Phase 2) at Brgy. Pagkakaisa, Naujan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount FOUR HUNDRED NINETY SEVEN THOUSAND SIX HUNDRED FORTY PESOS AND 96/100 ONLY (Php 497,640.96) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
