CONTRACT AGREEMENT

THIS AGREEMENT, made this JUN 24 2020 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **GEMWEALTH CONSTRUCTION AND TRADING CORP.** with office address at Lapu-lapu, Ibaan, Batangas represented by **CLYDE E. SOTTO**, the Authorized Managing Officer, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Construction of Multi-Purpose Building at Biga, Pola, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **ONE MILLION NINE HUNDRED EIGHTY NINE THOUSAND THREE HUNDRED THIRTY SIX PESOS AND 58/100 ONLY (Php 1,989,336.58)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

  - D. Performance Security
  - E. Credit Line or Net Financial Contracting Capacity.
  - F. PERT/CPM Diagram and bar chart with S-curve.
  - G. Other documentary requirements

3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein conformity with the provisions of this Contract in all respects.
4. The Entity hereby covenants to pay the Contractor in consideration of execution and completion of the Works and the remedying of defects therein, the Contract Price or such other sum as may become payable.
