CONTRACT AGREEMENT

THIS AGREEMENT, made this JUN 26 2020 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and GEMWEALTH CONSTRUCTION AND TRADING CORP. with office address at Lapu-lapu, Ibaan, Batangas represented by CLYDE E. SOTTO, the Authorized Managing Officer, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at Sitio Baracan 1 and 2 Brgy. Tagumpay, Baco, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED EIGHTY SEVEN THOUSAND NINE HUNDRED SIXTY ONE PESOS & 99/100 ONLY (Php 987,961.99) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
