INVITATION TO BID IB NO. CW 2020 - 073

Construction of 24/7 Oriental Mindoro Rescue Center

1. The Provincial Government of Oriental Mindoro (PGOM) through the 5% Local Disaster Risk Reduction Management Fund for FY 2019 intends to apply the sum of **Seven Million Four Hundred Thirty Four Thousand Seven Hundred Eighty Four Pesos and 76/100 only (Php 7,434,784.76)** being the approved Budget for the Contract (ABC) to payment under the contract for "**Construction of 24/7 Oriental Mindoro Rescue Center**". Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PGOM now invites bids for "**Construction of 24/7 Oriental Mindoro Rescue Center**". Completion of the Works is **176 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
