**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
 RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
 (INFRASTRUCTURE)**

WHEREAS, there is an infrastructure project funded through the 20% DF 2019 SB #2 to be undertaken by the Provincial Government of Oriental Mindoro for the **Concreting of Road at Brgy. Batong Dalig, Socorro, Oriental Mindoro (Concreting of Road: PCCP: L1 of PCCP=78.00m; W1 of PCCP=4.00m; T1 of PCCP=0.23m; Thk1 201=0.30m; : L2 of PCCP=57.00m; W2 of PCCP=5.00m; T2 of PCCP=0.23m; Thk2 201=0.20m; Flared at L2 (2m width, 4.5m length) with 1m shoulder BW; SHOULDER: Width 1 BW=1.00m; Width 2 BW=1.00m);**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2020-085) in PhilGEPS Website on **June 6, 2020** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the the **Concreting of Road at Brgy. Batong Dalig, Socorro, Oriental Mindoro (Concreting of Road: PCCP: L1 of PCCP=78.00m; W1 of PCCP=4.00m; T1 of PCCP=0.23m; Thk1 201=0.30m; : L2 of PCCP=57.00m; W2 of PCCP=5.00m; T2 of PCCP=0.23m; Thk2 201=0.20m; Flared at L2 (2m width, 4.5m length) with 1m shoulder BW; SHOULDER: Width 1 BW=1.00m; Width 2 BW=1.00m);**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. GEMWEALTH CONSTRUCTION AND TRADING CORP.

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **June 26, 2020**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as **"Government Procurement Reform Act and its Implementing Rules and Regulations"**;

WHEREAS, during the opening of Bid on **June 26, 2020** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **GEMWEALTH CONSTRUCTION AND TRADING CORP.** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
