INVITATION TO BID IB NO. CW 2020 - 092

Concreting of Balite-Pachoca-Lalud Road, Calapan City, Oriental Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the 20% Development Fund CA 2019 intends to apply the sum of Three Million Nine Hundred Fifty Seven Thousand One Hundred Forty Eight Pesos and 43/100 Only/(Php 3,957,148.43) being the approved Budget for the Contract (ABC) to payment under the contract for "Concreting of Balite-Pachoca-Lalud Road, Calapan City, Oriental Mindoro" Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Concreting of Balite-Pachoca-Lalud Road, Calapan City, Oriental Mindoro". Completion of the Works is 107 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
