CONTRACT AGREEMENT

THIS AGREEMENT, made this AUG 19 2020 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and NAMNAMA CONSTRUCTION SUPPLIES with office address at San Mariano, Roxas, Oriental Mindoro represented by REYNALDO C. GARABILES, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road Leading to Parola at Brgy. San Jose, Roxas, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION NINE HUNDRED THIRTY SIX THOUSAND SEVEN HUNDRED PESOS AND 12/100 ONLY (Php 1,936,700.12) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
