CONTRACT AGREEMENT

THIS AGREEMENT, made this AUG 10 2020 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and NAMNAMA CONSTRUCTION SUPPLIES with office address at San Mariano, Roxas, Oriental Mindoro represented by REYNALDO C. GARABILES, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at Brgy. Mabuhay, Roxas, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION NINE HUNDRED THIRTY NINE THOUSAND ONE HUNDRED SIXTY SIX PESOS & 88/100 ONLY (Php 1,939,166.88) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
