CONTRACT AGREEMENT

THIS AGREEMENT, made this AUG 14 2020 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and GEMWEALTH CONSTRUCTION AND TRADING CORP. with office address at Lapu-lapu, Ibaan, Batangas represented by CLYDE E. SOTTO, the Authorized Managing Officer, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at Roma, Mansalay, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION FOUR HUNDRED SEVENTY TWO THOUSAND ONE HUNDRED ELEVEN PESOS AND 28/100 ONLY (Php 1,472,111.28) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
