**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

Resolution No. 094, Series of 2020

WHEREAS, there is an infrastructure project funded through the **PDRRM Trust Fund 2015** to be undertaken by the Provincial Government of Oriental Mindoro for the **Completion of Evacuation Center at Maasin and Balatasan, Bulalacao, Oriental Mindoro (Completion of 6m x 8m Maasin (s) and 8m x 12m Balatasan Evacuation Center)**;

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2020-099-A) in PhilGEPS Website on **July 10, 2020** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for **Completion of Evacuation Center at Maasin and Balatasan, Bulalacao, Oriental Mindoro (Completion of 6m x 8m Maasin (s) and 8m x 12m Balatasan Evacuation Center)**;

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. ADL CONSTRAK

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **July 20, 2020**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **July 20, 2020** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **ADL CONSTRAK** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **July 20, 2020** found out that bid price of **ADL CONSTRAK** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;

WHEREAS, upon careful examination, validation and verification of eligibility, technical, financial requirements submitted by **ADL CONSTRAK** with **Single Calculated Bid**, its bid passed the post qualification process conducted on **July 22, 2020**, thereby making its bid found to be responsive;

NOW, THEREFORE, We the Members of the Bids and Awards Committee, in our meeting on **Aug. 03, 2020** hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a) To declare **ADL CONSTRAK** with business address at **FGY St., Sta. Fe, Bagumbayan, Roxas, Oriental Mindoro** as the bidder with **Single Calculated Responsive Bid**.
