THIS AGREEMENT, made this ________ between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and SANDBANK CONSTRUCTION AND DEVELOPMENT with office address San Nicolas, Naujan, Oriental Mindoro represented by CAROL VERNETTE R. ESTARES, General Manager, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Infrastracture Project (Phase II) for Oriental Mindoro Rehabilitation and Recovery Center, Brgy. Ilaya, Calapan City, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount TWO MILLION SEVEN HUNDRED EIGHTY THREE THOUSAND EIGHT HUNDRED NINETY ONE PESOS & 86/100 ONLY (Php 2,783,891.86) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
