**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
 RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
 (INFRASTRUCTURE)**

WHEREAS, there is an infrastructure project funded through the **20% Development Fund SB #1** to be undertaken by the Provincial Government of Oriental Mindoro for the **Repair/Rehabilitation of Health Center @ Pasi II, Socorro, Or. Mindoro/ Repair of health Center with Extension at Mabuhay II, Socorro, Oriental Mindoro and Repair of Health Center at Zone II, Socorro, Oriental Mindoro (Repair of Health Center; Repair of Health Center Extension; Removal of existing roofing and installation of new roof (frame included); Installation of Ceiling, Tiles and Doors and Windows and Grills; Repair of Health Center; Installation of doors and windows, paintings);**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2020-104) in PhilGEPS Website on **July 10, 2020** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Repair/Rehabilitation of Health Center @ Pasi II, Socorro, Or. Mindoro/ Repair of health Center with Extension at Mabuhay II, Socorro, Oriental Mindoro and Repair of Health Center at Zone II, Socorro, Oriental Mindoro (Repair of Health Center; Repair of Health Center Extension; Removal of existing roofing and installation of new roof (frame included); Installation of Ceiling, Tiles and Doors and Windows and Grills; Repair of Health Center; Installation of doors and windows, paintings);**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. PPG CONSTRUCTION CORPORATION

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **July 20, 2020**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as **"Government Procurement Reform Act and its Implementing Rules and Regulations"**;

WHEREAS, during the opening of Bid on **July 20, 2020** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **PPG CONSTRUCTION CORPORATION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **July 20, 2020** found out that bid price of **PPG CONSTRUCTION CORPORATION** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;
