(INFRASTRUCTURE)**

WHEREAS, there is an infrastructure project funded through the **20% Development Fund 2020** to be undertaken by the Provincial Government of Oriental Mindoro for the **Construction of Day Care Center at Sampaguita, Victoria, Oriental Mindoro (Const. of 7.00m x 9.00m Conc bldg. w/ 0.40m embankment, Ceiling, Painting and Tileworks at C.R. only)**;

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2020-109-A) in PhilGEPS Website on **August 07, 2020** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for **Construction of Day Care Center at Sampaguita, Victoria, Oriental Mindoro (Const. of 7.00m x 9.00m Conc bldg. w/ 0.40m embankment, Ceiling, Painting and Tileworks at C.R. only)**;

WHEREAS, in response to the said advertisement, one (1) prospective bidder/contractor submitted application for eligibility and purchased bid documents;

1. LINKS BUILDERS AND ENTERPRISES

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **August 26, 2020**, the bids were received until 8:30 am and opened thereafter in accordance with the provisions of R.A. 9184 otherwise known as "Government Procurement Reform Act and its Implementing Rules and Regulations";

WHEREAS, during the opening of Bid on **August 26, 2020** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **LINKS BUILDERS AND ENTERPRISES** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
