**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
 RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
 (INFRASTRUCTURE)**

WHEREAS, there is an infrastructure project funded through the **20% Development Fund 2020** to be undertaken by the Provincial Government of Oriental Mindoro for the **Construction of Montemayor – Herrera Road, Naujan, Oriental Mindoro (Construction of Road: ROAD: L of Road=446.50m; W of Road=5.00m; Thk 201=0.30; WITH 4 BARREL BOX CULVERT; SHOULDER: 1 m. SHOULDER BOTHSIDE);**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2020-113-A) in PhilGEPS Website on **August 07, 2020** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the the **Construction of Montemayor – Herrera Road, Naujan, Oriental Mindoro (Construction of Road: ROAD: L of Road=446.50m; W of Road=5.00m; Thk 201=0.30; WITH 4 BARREL BOX CULVERT; SHOULDER: 1 m. SHOULDER BOTHSIDE);**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. GEMWEALTH CONSTRUCTION AND TRADING CORP.

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **August 26, 2020**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of R.A. 9184 otherwise known as **“Government Procurement Reform Act and its Implementing Rules and Regulations”**;

WHEREAS, during the opening of Bid on **August 26, 2020** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **GEMWEALTH CONSTRUCTION AND TRADING CORP.** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
