**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

WHEREAS, there is an infrastructure project funded through the **General Fund 2020** to be undertaken by the Provincial Government of Oriental Mindoro for the **Rehabilitation of Barangay Hall at Manihala, Bansud, Oriental Mindoro (Remove & Replacement of Trusses, Roofing, Doors & Windows. Extension of 2m x 10.2m Terrace & 2m x 6.2m office & Kitchen; Replastering of Structure; Ceiling Works inside only Terrace not included);**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2020-122) in PhilGEPS Website on **July 27, 2020** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for **Rehabilitation of Barangay Hall at Manihala, Bansud, Oriental Mindoro (Remove & Replacement of Trusses, Roofing, Doors & Windows. Extension of 2m x 10.2m Terrace & 2m x 6.2m office & Kitchen; Replastering of Structure; Ceiling Works inside only Terrace not included);**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. 811 TRADING & CONSTRUCTION

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **August 26, 2020**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **August 26, 2020** eligibility check was conducted to one **bidder/contractor** mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **811 TRADING & CONSTRUCTION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **August 26, 2020** found out that bid price of **811 TRADING & CONSTRUCTION** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;
