(INFRASTRUCTURE)**

WHEREAS, there is an infrastructure project funded through the **General Fund 2020** to be undertaken by the Provincial Government of Oriental Mindoro for the **Rehabilitation of Covered Court at Tawagan, Calapan City, Oriental Mindoro (Completion of covered court & repair of stage. Construction of 1-half span of covered court. Painting of 1 unit pedestal. Replacement of purlins and roof sheets of stage. Construction of 9.0 L.m. bleachers);**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2020-124) in PhilGEPS Website on **August 03, 2020** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for **Rehabilitation of Covered Court at Tawagan, Calapan City, Oriental Mindoro (Completion of covered court & repair of stage. Construction of 1-half span of covered court. Painting of 1 unit pedestal. Replacement of purlins and roof sheets of stage. Construction of 9.0 L.m. bleachers);**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. SANDBANK CONSTRUCTION AND DEVELOPMENT

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **August 26, 2020**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **August 26, 2020** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **SANDBANK CONSTRUCTION AND DEVELOPMENT** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
