BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT (INFRASTRUCTURE)

## Resolution No. 104, Series of 2020

WHEREAS, there is an infrastructure project funded through the 20% Developmement Fund 2020 to be undertaken by the Provincial Government of Oriental Mindoro for the Installation of Water Tank at Joson Falls and Provision of HDPE pipes at Arangin, Naujan, Oriental Mindoro (Construction of Elevated Conc. Tank and Installation of HDPE pipes at Joson falls to proposed elev. Tank and existing conc. Tank);

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2020-139) in PhilGEPS Website on August 11, 2020 and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for Installation of Water Tank at Joson Falls and Provision of HDPE pipes at Arangin, Naujan, Oriental Mindoro (Construction of Elevated Conc. Tank and Installation of HDPE pipes at Joson falls to proposed elev. Tank and existing conc. Tank);

WHEREAS, in response to the said advertisement, one (1) prospective bidder/contractor submitted application for eligibility and purchased bid documents;

## 1. SOSEP BUILDERS

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on August 19, 2020, the bids were received until 8:30 am and opened thereafter in accordance with the provisions of R.A. 9184 otherwise known as "Government Procurement Reform Act and its Implementing Rules and Regulations";

WHEREAS, during the opening of Bid on August 19, 2020 eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by SOSEP BUILDERS was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on August 19, 2020 found out that bid price of SOSEP BUILDERS is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the Single Calculated Bid;
