**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

Resolution No. 106, Series of 2020

WHEREAS, there is an infrastructure project funded through the **General Fund 2020** to be undertaken by the Provincial Government of Oriental Mindoro for the **Completion of Evacuation Center at Buhuan, Calapan City, Oriental Mindoro (Completion of evacuation center with installation of cornisa for ceiling, concrete toppings for canopy w/ sahara, tileworks, painting works (inside, outside, ceiling, gutter & doors), grills (for all the windows) and cabinets);**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2020-141) in PhilGEPS Website on **August 11, 2020** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for **Completion of Evacuation Center at Buhuan, Calapan City, Oriental Mindoro (Completion of evacuation center with installation of cornisa for ceiling, concrete toppings for canopy w/ sahara, tileworks, painting works (inside, outside, ceiling, gutter & doors), grills (for all the windows) and cabinets);**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. RADEL CONSTRUCTION

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **August 19, 2020**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **August 19, 2020** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **RADEL CONSTRUCTION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **August 19, 2020** found out that bid price of **RADEL CONSTRUCTION** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;

- a) To declare **RADEL CONSTRUCTION** with business address at **Along C-5 Road, Sta. Isabel, Calapan City, Oriental Mindoro** as the bidder with **Single Calculated Responsive Bid**.
