BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT (INFRASTRUCTURE)

Resolution No. 110, Series of 2020

WHEREAS, there is an infrastructure project funded through the **20% Development Fund 2020** to be undertaken by the Provincial Government of Oriental Mindoro for the **Construction of Day Care Center at Balugo Mansalay, Oriental Mindoro (Demolition of Old Day Care Center; Construction of Footing, Column for Ground Floor, Tie Beam; Floor Beam, Flooring and Slab for Second Floor; Embankment of 0.5m from N.G.L.);**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2020-145) in PhilGEPS Website on **August 12, 2020** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for **Construction of Day Care Center at Balugo Mansalay, Oriental Mindoro (Demolition of Old Day Care Center; Construction of Footing, Column for Ground Floor, Tie Beam; Floor Beam, Flooring and Slab for Second Floor; Embankment of 0.5m from N.G.L.);**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. WTL CONSTRUCTION

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **August 19, 2020**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as **"Government Procurement Reform Act and its Implementing Rules and Regulations"**;

WHEREAS, during the opening of Bid on **August 19, 2020** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **WTL CONSTRUCTION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **August 19, 2020** found out that bid price of **WTL CONSTRUCTION** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;
