EXECUTIVE ORDER NO. 06 Series of 2022

AN EXECUTIVE ORDER REORGANIZING THE PROVINCIAL HEALTH BOARD, PROVIDING FOR ITS FUNCTIONS, AND FOR OTHER PURPOSES

WHEREAS, Section 102 of the Local Government Code of 1991 provides for the mandatory creation of a local health board in every local government unit;

WHEREAS, pursuant to Universal Health Care Act and Department of Health (DOH) Administrative Order No. 2020-0021, representatives from the municipalities and component cities included in the province-wide health system, and indigenous cultural communities or indigenous people (ICC/IP), in addition to the composition mandated by the Local Government Code of 1991, shall be represented in the Provincial Health Board (Board);

WHEREAS, there is a need to reorganize the composition of the Provincial Health Board due to organizational changes in some the members;

WHEREAS, on 15 February 2022, the current members of the Board discussed matters related to the implementation of Universal Health Care Act, and to expand the composition of the Provincial Health Board's members;

NOW THEREFORE, I, HUMERLITO A. DOLOR, MPA, PH.D., by virtue of the powers vested in me by Republic Act No. 7160 and other pertinent laws of the Republic of the Philippines as the Provincial Governor of Oriental Mindoro, do hereby promulgate this Executive Order, as follows:

SECTION 1. Reorganization. The Provincial Health Board is hereby reorganized to be composed of the following:

SECTION 2. Functions. The Provincial Health Board shall perform the following functions:

- a. Propose to the Sangguniang Panlalawigan, in accordance with the standards and criteria set by the DOH, annual budgetary allocations for the operation and maintenance of health facilities and services within the province;
- b. Serve as an advisory committee to the Sangguniang Panlalawigan on health matters such as, but not limited to, the necessity for, and application of local appropriations for public health purposes;
- c. Consistent with the technical and administrative standards of the doh, create committees which shall advise local health agencies on matters such as, but not limited to, personnel selection, bids and awards, grievance and complaints, personnel discipline, budget review, operations review, and other similar functions;
- d. Set the overall health policy directions and strategic thrusts, including the development and implementation of the integrated strategic and investment plans of the Province-Wide Health System (PWHS);
- e. Oversee and coordinate the integration and delivery of health services across health care continuum for PWHS;
- f. Assume full responsibility in the management of the special health fund and ensure that it is optimally utilized to help achieve desired health outcomes; and
- g. Exercise administrative and technical supervision over health facilities and health human resources within their respective territorial jurisdiction. The Board shall generally oversee the operations of the PWHS and ensure that they are managed effectively, efficiently, and economically.

The health board may require the submission of reports, initiate the conduct of management audit, performance evaluation, and inspection to determine compliance with policies, standards, and guidelines of the DOH, and take appropriate actions as may be necessary for the proper performance of its official functions. Such actions, however, shall not extend to appointment and other personnel actions which remain within the authority of concerned LGUs.

SECTION 3. Secretariat. The Provincial Health Office shall serve as Secretariat of the Provincial Health Board.

SECTION 4. Meetings and Quorum. The Provincial Health Board shall meet at least once a month or as often as may be necessary.

A majority of all its members shall constitute a quorum. However, the Chairperson or the Vice-Chairperson must be present during meetings where the Local Investment Plan for Health (LIPH),

Annual Operational Plan (AOP), and annual budgetary proposals are being prepared or considered.


The affirmative vote of a majority of all members is necessary to approve health systems plans and budgetary proposals. The affirmative vote of a majority of the members present is sufficient to approve matters relating to ordinary business.

SECTION 5. Separability Clause. If any provision of this Executive Order is declared invalid, illegal, or unconstitutional, the parts not affected shall remain valid and in full force.

SECTION 6. Repealing Clause. All executive orders, rules and regulations, issuances, or parts thereof inconsistent with this Executive Order are hereby amended, repealed and/or modified accordingly.

SECTION 7. Effectivity. This Executive Order shall take effect immediately upon its approval.
