EXECUTIVE ORDER NO. 21 Series of 2022

AN EXECUTIVE ORDER REORGANIZING THE MEMBERSHIP OF THE PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO (PGOM) BIDS AND AWARDS COMMITTEES (BAC) FOR INFRASTRUCTURE AND FOR GOODS AND SERVICES, ESTABLISHING A BAC FOR HEALTH, PROVIDING FOR THEIR FUNCTIONS, AND FOR OTHER PURPOSES

WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, as amended, and its revised implementing rules and regulations direct the establishment of Bids and Awards Committee (BAC) to spearhead procurement of goods, services, infrastructure projects, and consultancy services necessary in the local government unit's operations;

WHEREAS, various Executive Orders were issued to create and organize the Provincial Government of Oriental Mindoro's Bids and Awards Committees for Infrastructure, for Goods and Services with approved budget for contract (ABC) below One Million Pesos (PhP1,000,000.00), and for Goods and Services with ABC above One Million Pesos (PhP1,000,000.00);

WHEREAS, there is a need to reorganize PGOM's existing Bids and Awards Committees and to constitute an additional BAC for the procurement of medicines, goods and services for PGOM-operated hospitals, and other matters for the implementation of Republic Act No. 11223, also known as the Universal Health Care Act;

NOW THEREFORE, I, HUMERLITO A. DOLOR, MPA, Ph. D., by virtue of the power vested in me as the Provincial Governor of Oriental Mindoro by Section 465(b) (iii), Article I, Chapter 3, Title 4, Book III of Republic Act No. 7610, otherwise known as the "Local Government Code of 1991", do hereby promulgate the Executive Order as follows:

SECTION 1. Reorganization. The following Bids and Awards Committees of the Provincial Government of Oriental Mindoro are hereby reorganized, to be composed of the following:

In adherence to Section 12.4 of the Revised Implementing Rules and Regulations of RA No. 9184, the Vice Chairperson shall preside at all the BAC meetings in the absence of the Chairperson. Said meetings shall be valid and binding as an act of the BAC as long as there is a quorum. In such cases, the Vice Chairperson, shall vote only in case of a tie.

SECTION 3. Bids and Awards Committee for the Health. A BAC for the procurement of medicines, medical equipment, goods and services for PGOM-operated hospitals, and other matters relative to the implementation of the Universal Health Care is hereby created. It shall be referred to as the BAC for Health.

SECTION 4. Composition of the Bids and Awards Committee for Health. The BAC for Health shall be composed of the following:

SECTION 6. Functions and Responsibilities of the PGOM Bids and Awards Committees. The aforementioned Bids and Awards Committees for Infrastructure, for Goods and Services with approved budget for contract (ABC) above One Million Pesos (PhP1,000,000.00), for Goods and Services with approved budget for contract (ABC) below One Million Pesos (PhP1,000,000.00), and for Health shall exercise the functions stipulated in Republic Act No. 9184, as amended, and its revised implementing rules and regulations.

SECTION 7. Term of Office of the BAC Members. Unless sooner removed for cause, the members of the Bids and Awards Committees shall only serve until 30 June 2025.


SECTION 8. Transitory Provision. All procurement transactions and duties commenced prior to the assumption of the newly reorganized Bids and Awards Committees shall be continued and concluded by the outgoing BAC. Hence, the latter is hereby ordered to expedite the procurement process.

SECTION 9. Separability Clause. If any portion of this Executive Order is declared unconstitutional or invalid, other parts of the provision thereof which are not affected shall continue to remain in full force and effect.

SECTION 10. Repealing Clause. All executive orders, rules, regulations, and other issuances, including other parts thereof inconsistent with the provisions of this Executive Order are hereby amended or repealed accordingly.

SECTION 11. Effectivity. This Executive Order shall take effect immediately upon its approval.
