EXECUTIVE ORDER NO. 27 Series of 2022

AN EXECUTIVE ORDER CREATING THE EXECUTIVE COMMITTEE, WORKING COMMITTEE, AND ADMINISTRATION SUPPORT COMMITTEE FOR THE CELEBRATION OF THE FIESTA MAHAL TANA: THE 72nd FOUNDING ANNIVERSARY OF ORIENTAL MINDORO, PROVIDING FOR THEIR FUNCTIONS AND FOR OTHER PURPOSES

WHEREAS, the Province of Oriental Mindoro will be celebrating its 72nd Founding Anniversary on 15 November 2022;

WHEREAS, the Provincial Government of Oriental Mindoro spearheads the annual celebration to commemorate its establishment of its Founding Anniversary;

WHEREAS, Provincial Ordinance 139-2022 otherwise known as the Provincial Tourism Code of Oriental Mindoro declares that the annual celebration of the province's founding anniversary shall be known as FIESTA MAHAL TANA: The Oriental Mindoro Founding Anniversary;

WHEREAS, the 72nd Founding Anniversary is another milestone for Oriental Mindoro and thorough preparation is necessary to ensure its success;

NOW, THEREFORE, I, HUMERLITO A. DOLOR, MPA, Ph.D., by the virtue of the powers vested in me as Provincial Governor of Oriental Mindoro by Section 465(b) (2) (ii), Article One, Chapter 3, Title 4, Book III of Republic Act 7160, otherwise known as the Local Government Code of 1991, do hereby promulgate this Executive Order as follows:

SECTION 1. Composition. The Executive Committee shall exercise overall supervision and management of all related programs, activities, and events of the FIESTA MAHAL TANA: The 72nd Founding Anniversary Celebration of Oriental Mindoro. It shall be composed of the following:

SECTION 2. Functions of the Executive Committee. The Executive Committee shall perform the following specific functions:

1. Provide overall direction, coordination and synchronization of the celebration's activities;
2. Call upon individuals and organizations of the government and the private sector for any assistance that may be necessary to carry out the event;
3. Review, evaluate and approve the general program of the province's anniversary celebration;
4. Draw up policies and guidelines in implementing the anniversary; and
5. Create other committees later on as deemed necessary.

SECTION 3. Functions of the Working Committee. The Working Committee shall be at the forefront in planning, preparation and implementation of programs, activities related to the FIESTA MAHAL TANA: The 72nd Founding Anniversary Celebration of Oriental Mindoro, specifically:

1. In-charge in the brainstorming, planning, organizing, leading and coordinating activities for the Founding Anniversary Celebration; and
2. Coordinate with partners and stakeholders for the successful staging of the activities;

SECTION 4. Function of the Administration Support Committee. The Administration Support Committee shall ensure that appropriate and necessary resources of the Provincial Government shall be made available in relation to all approved programs, activities, and events by the Executive Committee.

SECTION 5. Secretariat. The Tourism Public Affairs Division of the Provincial Tourism Office shall act as the Secretariat of the FIESTA MAHAL TANA: The 72nd Founding Anniversary Celebration of Oriental Mindoro. It shall provide administrative support and assistance to the Working Committee.

SECTION 6. Meetings. The Provincial Governor shall call meetings for the Founding Anniversary Celebration as the need arises.

SECTION 7. Funding. Expenses for the FIESTA MAHAL TANA: The 72nd Founding Anniversary Celebration of Oriental Mindoro shall be charged against available sources of fund.

SECTION 8. Adherence to COVID-19 Protocols. Activities for the FIESTA MAHAL TANA: The 72nd Founding Anniversary Celebration of Oriental Mindoro will be held in conducive venues where social distancing and basic health protocols shall be strictly observed. In


adherence to the mass gathering protocol, program organizers will ensure that all COVID-19 health and security protocols will be strictly followed and maintained. Minimum public health standards such as wearing of face masks, observance of at least one (1) meter physical distancing, mandatory checking of body temperature and provision of alcohol or sanitizer for public use will be in place.

The preparation and conduct of events and activities for the FIESTA MAHAL TANA: The 72nd Founding Anniversary Celebration of Oriental Mindoro shall adhere to the guidelines imposed by Executive Order No. 24, Series of 2022. In view thereof, events and activities participated by more than fifty (50) individuals must be reported to the Provincial Health Office and there shall be safety officer/s designated for said events and activities.

SECTION 9. Separability Clause. If any provision of this Executive Order is found to be unconstitutional or inconsistent with any national or local laws, ordinances or resolutions, all the other provisions hereof shall remain in full force and effect.

SECTION 10. Effectivity. This Executive Order shall take effect immediately upon approval.
