Completion of Health Center at Del Pilar, Naujan, Oriental Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the 20% Development Fund 2022 intends to apply the sum of One Million One Hundred Ninety Five Thousand Two Hundred Thirty Two Pesos and 12/100 Only (Php 1,195,232.12) being the Approved Budget for the Contract (ABC) to payment under the contract for "Completion of Health Center at Del Pilar, Naujan, Oriental Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Completion of Health Center at Del Pilar, Naujan, Oriental Mindoro". Completion of the Works is 55 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
