**Construction of Additional Second Phase of Multi-Purpose Building at OMNHS, Calapan City, Or. Mindro**

1. The **Provincial Government of Oriental Mindoro (PGOM)** through the **LGSF - DRRP Fund 2021** intends to apply the sum of **Five Hundred Seventy Nine Thousand Two Hundred Thirty Six Pesos and 68/100 Only (Php 579,236.68)** being the approved Budget for the Contract (ABC) to payment under the contract for **Construction of Additional Second Phase of Multi-Purpose Building at OMNHS, Calapan City, Or. Mindoro**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PGOM now invites bids for **“Construction of Additional Second Phase of Multi-Purpose Building at OMNHS, Calapan City, Or. Mindoro”**. Completion of the Works is **28 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
