The Provincial Government of Oriental Mindoro (PGOM) through the LGSF - DRRP Fund 2021 intends to apply the sum of **Seven Hundred Ninety Thousand Three Hundred Forty Nine Pesos and 87/100 Only (Php 790,349.87)** being the approved Budget for the Contract (ABC) to payment under the contract for **Repair of 1 CL in San Jose ES, Roxas, Or. Mindoro and Repair of 3 CL in Mansalay CS, Mansalay, Or. Mindoro**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The PGOM now invites bids for **Repair of 1 CL in San Jose ES, Roxas, Or. Mindoro and Repair of 3 CL in Mansalay CS, Mansalay, Or. Mindoro**. Completion of the Works is **52 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC.
