# Installation of Solar Streetlights at Barcenaga, Naujan, Or. Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the 20% Development Fund FY 2022 intends to apply the sum of Two Million Four Hundred Ninety Seven Thousand Six Hundred Eighty Six Pesos and 12/100 Only (Php 2,497,686.12) being the approved Budget for the Contract (ABC) to payment under the contract for "Installation of Solar Streetlights at Barcenaga, Naujan, Or. Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Installation of Solar Streetlights at Barcenaga, Naujan, Or. Mindoro". Completion of the Works is 47 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
