### INVITATION TO BID IB NO. CW 2022 – 113-A

#### Concreting of Road at Sitio San Juan, Balingayan, Calapan City, Or. Mindoro

1. The **Provincial Government of Oriental Mindoro (PGOM)** through the **LGSF - DRRP Fund 2021** intends to apply the sum of **Nine Hundred Ninety Four Thousand Eight Hundred Seventy Eight Pesos and 28/100 Only (Php 994,878.28)** being the approved Budget for the Contract (ABC) to payment under the contract for **Concreting of Road at Sitio San Juan, Balingayan, Calapan City, Oriental Mindoro**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PGOM now invites bids for **“Concreting of Road at Sitio San Juan, Balingayan, Calapan City, Oriental Mindoro”**. Completion of the Works is **34 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
