Salong Dagitab Festival Calapan City, Oriental Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the General Fund FY 2022 intends to apply the sum of Two Million Seven Hundred Ninety Nine Thousand Four Hundred Eighty Eight Pesos and 96/100 Only (Php 2,799,488.96) being the approved Budget for the Contract (ABC) to payment under the contract for "Salong Dagitab Festival Calapan City, Oriental Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Salong Dagitab Festival Calapan City, Oriental Mindoro". Completion of the Works is 66 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
