INVITATION TO BID IB NO. CW 2022 – 151

Installation of Solar Streetlights at Estrella, Naujan, Or. Mindoro

1. The **Provincial Government of Oriental Mindoro (PGOM)** through the **20% Development Fund FY 2022** intends to apply the sum of **Two Million Four Hundred Ninety Nine Thousand Two Hundred Seventy Four Pesos and 27/100 Only (Php 2,499,274.27)** being the approved Budget for the Contract (ABC) to payment under the contract for **"Installation of Solar Streetlights at Estrella, Naujan, Or. Mindoro"**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PGOM now invites bids for **"Installation of Solar Streetlights at Estrella, Naujan, Or. Mindoro"**. Completion of the Works is **47 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
