Rehabilitation of Day Care Center at Urdaneta, Victoria, Oriental Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the 20% Development Fund CA 2020 intends to apply the sum of Five Hundred Ninety Five Thousand One Hundred Ninety Five Pesos and 49/100 Only (Php 595,195.49) being the approved Budget for the Contract (ABC) to payment under the contract for "Rehabilitation of Day Care Center at Urdaneta, Victoria, Or. Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Rehabilitation of Day Care Center at Urdaneta, Victoria, Or. Mindoro". Completion of the Works is 41 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
