**Concreting of Road at Sta. Maria, Mansalay, Oriental Mindoro**

1. The Provincial Government of Oriental Mindoro (PGOM) through the 20% Development Fund FY 2022 intends to apply the sum of **One Million Four Hundred Ninety Four Thousand Eight Hundred Twelve Pesos and 60/100 Only (Php 1,494,812.60)** being the approved Budget for the Contract (ABC) to payment under the contract for "**Concreting of Road at Sta. Maria, Mansalay, Oriental Mindoro**". Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PGOM now invites bids for "**Concreting of Road at Sta. Maria, Mansalay, Oriental Mindoro**". Completion of the Works is **43 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
