INVITATION TO BID IB NO. CW 2022 - 157

Concreting of Road at B. Del Mundo, Mansalay, Oriental Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the 20% Development Fund FY 2022 intends to apply the sum of Nine Hundred Ninety Eight Thousand Seventy Two Pesos and 50/100 Only (Php 998,072.50) being the approved Budget for the Contract (ABC) to payment under the contract for "Concreting of Road at B. Del Mundo, Mansalay, Or. Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Concreting of Road at B. Del Mundo, Mansalay, Or. Mindoro". Completion of the Works is **35 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
