INVITATION TO BID IB NO. CW 2022 - 159

Concreting of Road Leading to Covered Court at Zone II, Pinamalayan, Or. Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the 20% Development Fund FY 2022 intends to apply the sum of Nine Hundred Ninety Eight Thousand Seven Hundred Fifty Six Pesos and 86/100 Only (Php 998,756.86), being the approved Budget for the Contract (ABC) to payment under the contract for "Concreting of Road Leading to Covered Court at Zone II, Pinamalayan, Or. Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Concreting of Road Leading to Covered Court at Zone II, Pinamalayan, Or. Mindoro". Completion of the Works is 35 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
