Rehabilitation/Widening of Road at Bangkatan, Baco, Oriental Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the 20% Development Fund FY 2022 intends to apply the sum of Nine Hundred Ninety Six Thousand Seven Hundred Thirty Three Pesos and 97/100 Only (Php 996,733.97) being the approved Budget for the Contract (ABC) to payment under the contract for "Rehabilitation/Widening of Road at Bangkatan, Baco, Or. Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Rehabilitation/Widening of Road at Bangkatan, Baco, Or. Mindoro". Completion of the Works is 40 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
