# Concreting of Farm to Market Road at So. Tres-Uno, San Narciso, Victoria, Or. Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the 20% Development Fund FY 2022 intends to apply the sum of Nine Hundred Ninety Nine Thousand Three Hundred Sixty Six Pesos and 72/100 Only (Php 999,366.72) being the approved Budget for the Contract (ABC) to payment under the contract for "Concreting of Farm to Market Road at So. Tres-Uno, San Narciso, Victoria, Or. Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Concreting of Farm to Market Road at So. Tres-Uno, San Narciso, Victoria, Or. Mindoro". Completion of the Works is 42 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
