EXECUTIVE ORDER NO. 50 Series of 2022

AN EXECUTIVE ORDER REORGANIZING THE COMPOSITION OF THE PROVINCIAL BAMBOO INDUSTRY DEVELOPMENT COUNCIL IN ORIENTAL MINDORO

WHEREAS, Executive Order No. 879, series of 2010, dated 14 May 2010 created the Philippine Bamboo Industry Development Council (PBIDC) to promote the bamboo industry development project and to direct the use of bamboo for at least twenty-five (25%) percent of the desk and other furniture requirements of public elementary and secondary schools and prioritizing the use of bamboo in furniture, fixtures and other construction requirements of government facilities.

WHEREAS, on 21 April 2021, the Provincial Government of Oriental Mindoro (PGOM) created the Provincial Bamboo Industry Development Council to formulate plans and implement management system that will ensure the sustainability of bamboos in the province.

WHEREAS, there is a need to change the composition of the Provincial Bamboo Industry Development Council in Oriental Mindoro pursuant to Sangguniang Panlalawigan Resolution No. 5810-2022, dated 4 July 2022, which provides for the new composition of Standing Committees of the 11th Sangguniang Panlalawigan of Oriental Mindoro, as appointed by the Presiding Officer.

WHEREAS, there were changes in government agency heads and other matters such as the change of PGOM Department name and inclusion of new PBIDC Members.

NOW, THEREFORE, I, HUMERLITO A. DOLOR, MPA, Ph. D., by virtue of the powers vested in me by Republic Act No. 7160 and other pertinent laws of the Republic of the Philippines as the Provincial Governor of Oriental Mindoro, do hereby promulgate this Executive Order, as follows:

SECTION 1. Reorganization of the Provincial Bamboo Industry Development Council. The Council is hereby reorganized with the following composition:

SECTION 2. Functions of the Council Chairperson. The Chairperson shall preside over the meetings of the Council and ensure the performance of the Council's duties and functions. He/she

may call for a special meeting as he/she may deem necessary to effectively implement the Bamboo Industry Development Program.

SECTION 3. Duties and Functions of the Oriental Mindoro Bamboo Industry Development Council. The Council shall have the following duties and functions:

- Identify problems and recommend measures in the planning, development, financing, marketing, and operation of bamboo industry in the province:
- ii. Formulate the fundamental policies for its effective operations and implement management system that will ensure the sustainability of bamboos in the province;
- iii. Conduct periodic assessment of the activities of the Technical Working Groups; and
- iv. Review the reports and other documents submitted by the TWGs;
- v. Perform such other functions as may be necessary.

SECTION 4. Council Secretariat. The Provincial Government - Environment and Natural Resources (PG-ENRO) shall serve as the Secretariat and shall perform the following functions:

- Compile all gathered information, data and materials related to the Council;
- ii. Arrange and coordinate meetings of the Council;
- iii. Record all proceedings and discussions that arise from the meetings; and
- iv. Perform such other functions as may be necessary.

SECTION 5. Technical Working Group for Research and Development (TWG-RD). The TWG-RD is hereby created and shall be composed of the following:

SECTION 6. TWG-RD Duties and Functions. The TWG-RD shall perform the following:

- i. Analyze the current situation of bamboo industry and perform measures such as project initiatives and implementation to ensure bamboo sustainability in the province;
- ii. Provide trainings and seminars to cooperatives, farmers, and/or persons regarding the cultivation, propagation, as well as the advantages and benefits of bamboo;
- iii. Conduct research for the innovation and value-addition of bamboo products, but also its wide-range application;
- iv. Submit an annual report to the Council:
- v. Coordinate with other persons and/or agencies in gathering and extending information to and from its respondents, and provide bamboo planting materials, if possible; and
- vi. Perform other tasks analogous to the foregoing and necessary to accomplish such objectives.

SECTION 8. TWG-OM Duties and Functions. The TWG-OM shall perform the following:

- Identify, introduce, and implement the integration of bamboo in the construction industry:
- ii. Provide technical trainings and livelihood seminars to cooperatives, farmers, and/or persons in relation to simple bamboo woodcrafts, bamboo furniture building, and integration of bamboo in the construction industry;
- iii. Disseminate information about the broad application of bamboos, its innovations, advantages, and benefits through media, trainings, flyers, and/or other lawful means to that effect;
- iv. Coordinate with other persons and/or agencies in the implementation of the mandate to promote and introduce the use of bamboo in government establishments; and
- v. Perform other tasks analogous to the foregoing and necessary to accomplish such objectives.

SECTION 9. Funding. The Council shall charge the expenses and other obligations necessary to perform their duties and functions against the Governor's Office.

SECTION 10. Local Bamboo Industry Council. Component Cities and Municipalities of the province may organize their own local bamboo industry council. The local council shall have the same duties and functions as the Provincial Council to be exercised within its territorial jurisdiction. The annual report of the local councils shall be submitted to the Provincial Council for the latter's review and evaluation.

SECTION 11. Repealing Clause. All executive orders, rules and regulations, and other issuances, or parts thereof inconsistent with this Executive Order are hereby amended, repealed and/or modified accordingly.

SECTION 12. Separability Clause. If any provision of this Executive Order is declared invalid, illegal, or unconstitutional, the parts not affected shall remain valid and in full force and effect.

SECTION 13. Effectivity. This Executive Order shall take effect immediately upon its approval.
